

A note on phone calls:

Phone calls are routinely surveilled and always stored, and handed over to prosecutors. Jailors may use information and weaknesses in your phone calls to extort, harass, or torture inmates. Assume every call has a cop listening because it does either now or later.



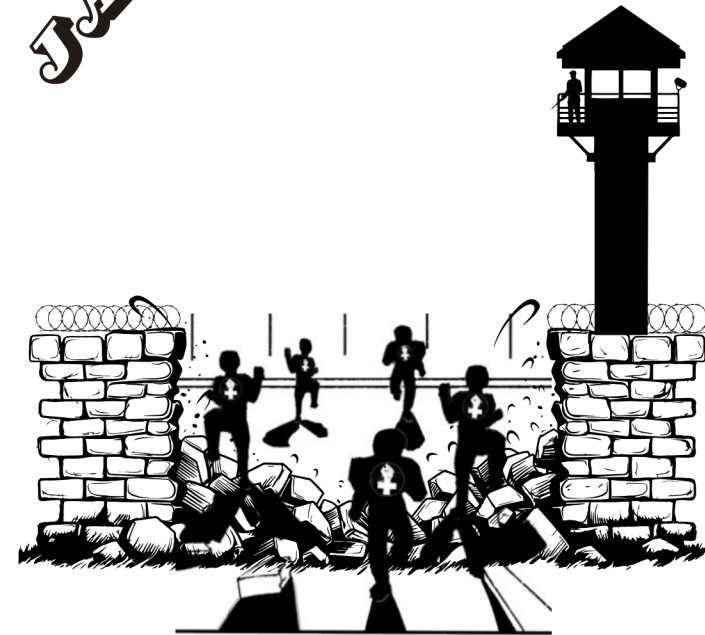
A note on commissary:

Even for short term stays, add at least a small amount of money. Take extra consideration for dietary restrictions. There are kosher and halal menus available but they will either cost money or be rarely accessible. Your loved one or friend is at the whims of what the jailor brings them and if they don't like them, they'll get the same slop as everyone else. Jail food is the absolute worst food you will ever encounter, soften the blow with soup and chips.

*While this sheet can be utilized to support our friends when they are arrested, we would encourage the use of this sheet to find and connect with random members of our community that are locked up. Many have little to no community or family support and can use all the help they can get. Even outside of times of uprising, the tinders of rage must be stoked. To us, the distinction between politically and non-politically motivated incarceration is meaningless when all crime is inherently political. If we're going to burn this whole system down, it will take every single prisoner inside striking a match.*

**Visitors** are by video only or from pod kiosk on Woodrow Ln. Before remote visitation, create an account on Homewav.com. Remote visits can only be initiated by inmates, not visitors. Once you register and "go online", inmates can see your account and begin the video chat.

**Phone** account must be setup through Securus to receive phone calls. This can be done through the Securus website at [www.securustech.net](http://www.securustech.net) or over the phone when your homie calls you the first time.

Handwritten or typed letters and softback books from recognized publishers are allowed.

**Visitors** must be on approved visitors card, which can be updated every 90 days. Visitation is seperated by inmate last name, consult county website for day desigation.

**Phones**-After booking, all phone calls are collect and processed by Securus. Inmates are not allowed to receive phone calls, only outgoing calls are allowed and you're extorted for it. An account to charge will need to be setup before you can receive a phone call but this can be done with Securus when your loved one/homie calls you the first time.

**Funds**-can be added online through [www.accesscorrections.com](http://www.accesscorrections.com), by calling 866-345-1884 24/7 and speak to a representative in English or Spanish or on-site through the lobby kiosk. To deposit cash on-site you must enroll on [cashpaytoday.com](http://cashpaytoday.com) and verify your account.

Handwritten or typed letters on plain paper accepted, 10 or less 4"x 6" or smaller pictures allowed (no polaroid), New softbacked books from recognized book sellers allowed. Jail will only accept packages from USPS or UPS, Amazon couriers & packages not allowed.

**Visitors** must conform to the entirety of the "conservative" visitation dress code or can be refused but this is largely up to the mood of the pig at the desk judging your drip. Visitation days separated by inmate last name. Consult county site for days allowed.
